

PRIVACY NOTICE

In order to comply with the provisions of the Federal Law for the Protection of Personal Data in Possession of Private Parties (LFPDPPP) BARRERA Y NOGUEIRA, S. DE R.L. DE C.V. (hereinafter B&N Exposiciones), makes available to you this privacy notice and handling of personal data so that you - as Holder of the Personal Data (OWNER) - are informed about the treatment that will receive the personal data you provide us.

B&N Exposiciones, domiciled at 156 Hershel Street, 6th floor, colonia Anzures, delegation Miguel Hidalgo, C.P. 11590, in Mexico City, and with address www.bynexpo.com, is responsible for the use and protection of your personal data, and in this regard we inform you of the following:

PERSONAL DATA AND PURPOSES OF PROCESSING

The personal data that we will collect from you will be used for the following purposes that are necessary for the service you request:

- To confirm your identity.
- To carry out the registration of your attendance in the virtual event ANPACT 2021 and in the Expo Transporte ANPACT 2022.
- To elaborate the access badge for the virtual event 2021 and Expo Transporte ANPACT 2022.
- For your safety and that of the people who will attend the virtual event 2021 and Expo Transporte ANPACT 2022.
- To keep you informed of the activities that will take place in the virtual event 2021 and Expo Transporte ANPACT 2022.
- To make use of the exclusive application of Expo Transporte ANPACT 2022.

Additionally, the data collected will be used for the following purposes that are not necessary, but that allow and facilitate us to provide you with better service, attention and information:

- Sending commercial promotions.
- Sending invitations to different events in the automotive industry.
- Generation of statistics and market research.
- Marketing and advertising.
- Commercial prospecting.
- Creation of specialized audiences in online platforms and social networks.

If you do not want your personal data to be processed for these additional purposes, you may indicate so by submitting a free-format letter to the address of B&N Exposiciones or by sending an e-mail to info@bynexpo.com. If you do not express your refusal for such treatment in the terms indicated above, we will understand that you have given us your consent.

The refusal to use your personal data for these purposes shall not be a reason to cancel your participation in the market research in which you have confirmed that you will participate.

PERSONAL DATA WE WILL COLLECT

To carry out the purposes described in this privacy notice, we will use the following personal data:

- Identification data: name, address.
- Contact data: home and cell phone, e-mail.
- Data on physical characteristics (obtained through video).
- Employment data: position or position held.
- Personal interests.

We inform you that B&N Exposiciones may obtain your personal data through electronic communications that we establish with you, correspondence, audio, video, phone calls, messages through the WhatsApp social network or information provided through the website: www.bynexpo.com or through <https://expotransporte.com/encuentro-virtual.htm>. Derived from the above, B&N Exposiciones establishes and maintains administrative, technical and physical security measures to protect personal data against damage,



loss, alteration, destruction or unauthorized use, access or treatment.

TRANSFER OF PERSONAL DATA

We inform you that your personal data will be shared within and outside the country with the following persons, companies, organizations and authorities other than us, for the following purposes:

Organizations and/or Associations dedicated to the transportation sector.	To send you invitations to events in the transportation sector (*).
Advertising and marketing companies.	To offer you services that may be of interest to you, as well as special promotions and the creation of specialized audiences (*).
Companies dedicated to marketing through online platforms and social networks.	To offer you services that may be of interest to you, as well as special promotions and the creation of specialized audiences (*).

We also inform you that, for the transfers indicated with an asterisk (*) we require your consent, if you do not want your personal data to be transferred for such purposes, you can indicate it by submitting a free format letter at the address of B&N Exposiciones or by sending an email to info@bynexpo.com. If you do not express your refusal to such transfers, we will understand that you have given us your consent.

EXERCISE OF YOUR RIGHTS ARC (ACCESS, RECTIFICATION, CANCELLATION AND OPPOSITION)

You have the right to know what personal data we have about you, what we use them for and the conditions of the use we make of them (Access). Likewise, it is your right to request the correction of your personal information in case it is outdated, inaccurate or incomplete (Rectification); that we remove it from our records or databases when you consider that it is not being used properly (Cancellation); as well as to oppose the use of your personal data for specific purposes (Opposition). These rights are known as ARCO rights.

To exercise any of the ARCO rights, you must make the respective request to the Privacy Department, through any of the following means:

- By submitting a written request at the address of B&N Exposiciones located at 156 Hershel Street, 6th floor, colonia Anzures, delegation Miguel Hidalgo, C.P. 11590, in Mexico City.

Regarding the procedure and requirements for the exercise of your ARCO rights, we inform you of the following:

The information and/or documentation that the request must contain, is the following:

1. Name of the holder and address or other means of communicating the response to your request;
2. Simple copy in printed or electronic format of the documents that prove your identity -voter's credential, passport, professional license- or, if applicable, that of your legal representative (you must attach a simple power of attorney with autographic signature of the Holder, the attorney-in-fact and their corresponding official identifications);
3. The clear and precise description of the personal data with respect to which the exercise of any of the ARCO rights is sought;
4. Any other element or document that facilitates the location of the personal data.



In the case of requests for rectification of your personal data, you must also indicate the modifications to be made and provide the documentation supporting your request.

In the case of requests for access to personal data, B&N Exposiciones will proceed with its delivery, prior accreditation of your identity as owner or your legal representative, as appropriate, by issuing simple copies or electronic documents. The delivery of personal data will be free of charge, except for shipping costs or the cost of reproduction in copies or other formats, which must be paid by you or your Legal Representative.

We will respond to your request, within 20 working days from the receipt of such request through the means you have indicated in the same.

REVOCAION OF YOUR CONSENT

You may revoke the consent, if any, you have given us for the processing of your personal data. However, it is important to note that not in all cases we can meet your request or terminate the use immediately, since it is possible that some legal obligation may require us to continue processing your personal data. Also, you should consider that, for certain purposes, the revocation of your consent will imply the conclusion of your relationship with us.

To revoke your consent you must submit your request through the means indicated and following the procedure established in this Privacy Notice for the exercise of ARCO rights. The requirements for the revocation of consent are as follows:

1. Name of the holder and address or other means to communicate the response to your request;
2. Documents proving the identity or, as the case may be, legal representation of the holder;
3. The clear and precise description of the personal data with respect to which the revocation of consent is sought, indicating whether the revocation sought is total or partial; and
4. Any other element or document that facilitates the location of the personal data.

LIMITING THE USE AND DISCLOSURE OF YOUR PERSONAL INFORMATION

In order for you to limit the use and disclosure of your personal information, you must submit your request through the means indicated and following the procedure established in this Privacy Notice for the exercise of ARCO rights. The information and/or documentation that the request must contain is the following:

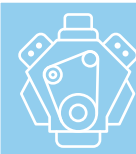
1. Name of the holder and address or other means to communicate the response to your request;
2. Documents proving the identity or, as the case may be, legal representation of the holder;
3. The clear and precise description of the personal data with respect to which the use or disclosure is sought to be limited; and
4. Any other element or document that facilitates the location of the personal data.
